

# Photovoltaic panel phase installation requirements and standards

What are the requirements for a PV installation?

Virtually all domestic PV installations will fall under the scope of Part P. Part P requires the relevant Building Control department to be notified and approve the work. There are two routes to comply with the requirements of Part P: Notify the relevant Building Control department before starting the work.

Are there any UK standards relating to a PV installation?

While many UK standards apply in general terms, at the time of writing there is still relatively little which specifically relates to a PV installation. However, there are two documents which specifically relate to the installation of these systems that are of particular relevance:

What is a roof mounted photovoltaic system guidance?

The guidance refers only to the mechanical installation of roof mounted integrated and stand-off photovoltaic systems; it provides best practice guidance on installation requirements and does not constitute fixing instructions.

Do I need a building regulations approval for a PV system?

Building Regulations approval may require the product to have passed the wind uplift, water penetration and spread of flame tests (see section 2.1.1.2). These will usually be applicable only where the PV is integrated into the fabric of the building.

Do solar PV systems need a professional inspection?

Ensure provisions are made for a competent person to carry these out, as necessary. As with other installed technology and appliances (for example, domestic and commercial boilers), all solar PV systems need professional inspection and maintenance to identify and resolve technical and other problems.

How should a PV system be designed & installed?

From the outset, the designer and installer of a PV system must consider the potential hazards carefully, and systematically devise methods to minimise the risks. This will include both mitigating potential hazards present during and after the installation phase.
