Why are US tariffs on solar panels coming to Southeast Asia?

Nov 29 (Reuters) - U.S. trade officials announced on Friday a new round of tariffs on solar panel imports from four Southeast Asian nations after American manufacturers complained that companies there are flooding the market with unfairly cheap goods.

Where are Chinese solar panels made?

The Chinese firms had set up factories in Southeast Asia, but Commerce Department officials said that some were not doing substantial manufacturing there. Rather, they were using sites in those countries to make minor changes to Chinese-made solar products, and then shipping them to the United States tariff-free, the ruling decided.

Where do US solar equipment imports come from?

Since the imposition of the Obama-era tariffs,the share of US solar equipment imports directly from Chinahas been almost completely phased out, with imports shifting to Southeast Asia. The recent DOC decision would expand these AD/CVD tariffs to cover imports from certain companies in Cambodia, Malaysia, Thailand, and Vietnam.

Which countries circumvent solar panels & modules?

Commerce has determined that circumvention occurred during the review period through each of the four Southeast Asian countries and made "country-wide" circumvention findings designating Cambodia,Malaysia,Thailand,and Vietnamas countries from which circumventing solar cells and modules are being exported.

Where are solar panels made?

(A) solar cells that were produced in Southeast Asia from wafers produced in China; and (B) modules, laminates, and panels that were produced in Southeast Asia from wafers produced in China, and where more than two of the following components in the modules were produced in China: (f) junction boxes.
