#### When will solar module imports be taxable?

Pursuant to the Presidential Proclamation issued on June 6,2022,duties will not be collected on any solar module and cell imports from these four countries until June 2024,as long as the imports are consumed in the U.S. market within six months of the termination of the President's Proclamation.
