What happened to the economy of Saint Pierre and Miquelon?

There was a short 13-year economic boom on the island associated with the period of Prohibition in the United States, when Saint Pierre and Miquelon were prominent bases for alcohol smuggling. This boom ended with the end of prohibition in 1933, and the economy sank into depression.

Does Saint-Pierre & Miquelon have a sustainable tourism sector?

Saint-Pierre and Miquelon benefits from a territorial envelope of EUR27 million for the period 2021-2027 and sustainable tourism has been selected as a priority sectorin the Multiannual Indicative Programme.

What are the top export opportunities for Saint Pierre and Miquelon?

The top export opportunities for Saint Pierre and Miquelon according to the relatedness index, were Crustaceans (0.049), Gold (0.046), Non-fillet Fresh Fish (0.046), Fish Fillets (0.045), and Scrap Iron (0.044). Relatedness measures the distance between a country's current exports and each product.

When did Canada establish the Exclusive Economic Zone of Saint Pierre & Miquelon?

The decision established the extent of the Exclusive Economic Zone of the French territory of Saint Pierre and Miquelon. In 1972, Canada and France signed a treaty that delimited the territorial maritime boundary between Canada and the French territory of Saint Pierre and Miquelon.

What is Saint Pierre and Miquelon specialization?

Saint Pierre and Miquelon has a high level of specialization in Processed Crustaceans (703), Molluscs (425), Pickled Foods (94.8), Non-fillet Frozen Fish (48.4), and Large Iron Containers (25.9). Specialization is measured using RCA, an index that takes the ratio between Saint Pierre and Miquelon observed and expected exports in each product.

How does the EU support Saint-Pierre-et-Miquelon?

On average, the EU has supported Saint-Pierre-et-Miquelon with a budget of EUR4 to EUR5 million per yearwith an approximate 40% contribution of the Collectivity's investments.
