Some scammers may say they're consultants from your power company, utilities warn.

#### How do I know if a solar contract is a scam?

Pay attention to warranties, cancellation policies, payment schedules, and try to spot any hidden fees. Honest businesses will give you time to go over the terms of the contract, understand the agreement, and let you sign it in writing. To learn more, visit ftc. gov /solar. And if you spot a scam, tell the FTC.

### Are solar energy companies scamming consumers?

As solar energy has boomed over the years, some companies " have preyed on consumers by offering predatory and costly loans, " and many of them " are engaging in overly aggressive sales tactics or are outright scamming consumers, " said CNET.

### What should I do if a solar business is a scam?

Protect your personal information. Don't respond to unexpected requests online or on social media for your name, address, or other personal information to "see if you qualify." At best, this is someone generating leads to sell, not actual solar businesses. At worst, they're scammers trying to steal your identity.

Be aware of solar energy scams - everything from scammers pretending to be affiliated with the government or utility company to businesses misrepresenting the cost of improvements, savings, and financing options.
