Will shell New Energies buy Savion?

Clean energy division Shell New Energies announced the move today in a press release issued on the Cision PR platform, but did not specify how much the acquisition will cost or how the deal will be structured. The Anglo-Dutch energy business will buy Savion from the Green Investment Group owned by Australian investor Macquarie.

Where is shell developing a battery?

What does Shell Energy's 20-year offtake agreement mean for Australia?

Shell will hold the rights to charge and dispatch energy from the battery through a 20-year offtake agreement. Shell Energy Australia Chief Executive Officer Greg Joiner said the project signals the company's commitment to accelerating the energy transition and contributing to growth of firming capacity.
