On June 25th 2024, SolarEdge plunged nearly 15% in early morning trading to \$28.41, down from an all-time-high of \$368.33 on November 15, 2021. SolarEdge was established in 2006 by Guy Sella, Lior Handelsman, Yoav Galin, Meir Adest and Amir Fishelov.

Did SolarEdge buy SMRE?

In January 2019 SolarEdge announced the acquisition of a majority stake in SMRE- an Italian EV powertrain manufacturer. In 2019 SolarEdge announced the acquisition of Gamatronic, a UPS manufacturer, and established its Critical Power division
