

What is the installation Notification Form for small generation installation procedure 1?

The installation notification form for Small Generation Installation Procedure 1 can be used to notify us that the Generating Units have been installed and commissioned where the eligibility conditions are met. All of the generation and/or storage equipment is located in a single installation.

How long do I have to notify you of a generation installation?

Installations take place on a fit and notify basis. You must notify us of the generation installation within 28 days of commissioning. Prefer paper? If you would prefer to download the form (s) that you need and then return them completed to us, you can do so by clicking the relevant links below.

How much documentation do I need for a solar generator?

The documentation required depends on the size of the solar generator. Generally, the larger the system, the more forms you'll need to fill out before installation. For solar power systems, the threshold is typically 16 amps per phase. The inverter's AC output helps determine your rated amp output.

How do I get a G98 notification?

Complete the G98 application form B and email to G98notifications@enwl.co.uk. If you're installing a generator or storage at multiple premises, we may need to carry out work on the network to accommodate your connection.

How do I get a DNO letter for solar panels?

To acquire a DNO (Deed of Non-Objection) letter for installing solar panels, start by researching local regulations and utility company requirements. Then, submit a formal application detailing your proposed solar panel installation plans, including system specifications and any relevant technical information.

What is a DNO solar application?

The DNO solar application is typically made by individuals, businesses, or organisations seeking to connect renewable energy sources, such as solar panels or wind turbines, to the grid or to make alterations to the existing electrical connections.
