This includes: Proof of Ownership: A document that proves you are the owner of the property and the solar panel system.

Do I need prior permission to install a solar PV system?

Prior permission is not required as the addition of such small systems is very unlikely to cause any load issues to the current infrastructure of the local grid. However, if the solar PV system to be installed is greater than 16A per phase then prior permission will need to be granted.

How long does it take to register an energy device?

If MCS certified, the installation contractor must register the energy device with MCS 's Microgeneration Installation Database (MID) within 10 daysof installation. If TrustMark registered, and work is funded by certain energy efficiency schemes, the installation contractor must register the installation in the TrustMark Data Warehouse.

Do solar PV installations need to be MCs certified?

Also,the Council of Mortgage Lenders has advised that,as a minimum to avoid the risk of a property being ineligible for a mortgage,both new and existing Solar PV installations must be MCS certified. All renewable energy products are examined by certification bodies against MCS manufacturing and testing standards.
