Why is South Korea implementing a Bess frequency regulation project?

South Korea is in the midst of the world's largest BESS frequency regulation project. The target is to install 500MW by 2017. In addition to enhancing the efficiency of the grid, installing BESS capacity will reduce KEPCO's need for readily available spinning reserve capacity.

For the BESS programme the government has lifted many of the stringent local content requirements that normally apply to state-driven capital projects - such as, for example, the national Renewable Energy Independent Power Producer Procurement Programme (REIPPPP).

Why are Eskom Bess projects so short?

"The fact that the initial BESS projects have unusually short lead times to completion works to the advantage of local suppliers already in good standing with Eskom, as their already approved products are saved from the time-consuming design and approval processes which many overseas suppliers will be obliged to go through.
