The key provisions of this policy include connecting large-scale independent power providers and many distributed renewable energy systems to the electrical grid. The work force needs of Aera are provided by Aera Energy Services Company(Aera Services), a Delaware corporation. Aera and Aera Services employ about 1,100 people and hundreds of contractor companies.
