Sudan faces many energy development challenges brought about by high electricity subsidy levels and climate-induced impacts on hydroelectric generation which has been decreasing at a rate of about 4% per year. Improving access to modern and afordable energy a development priority for Sudan.

How do solar power systems work in Sudan?

Concentrated solar power systems are also potential options for Sudan. These systems generate electricity when concentrated light is converted to heat which drives a steam turbine connected to an electrical power generator. There are several types of systems available, including parabolic troughs, solar towers, stirling dishes, among others.

What are the potential uses of wind energy in Sudan?

Wind: The major potential uses of wind energy in Sudan are for electricity generation and mechanical power. Wind turbine technology for electricity generation consists of the turbine itself which can be oriented along either the vertical or the horizontal axis.
