Why did Sapura Energy terminate Yunlin wind power company?

TAIPEI, February 7, 2022 - Sapura Energy has issued a termination notice to Yunneng Wind Power Company for transportation and installation of monopiles at the 640-MW Yunlin offshore wind farm, the Malaysian integrated energy company announced on Friday.
