The new U.S. Trade Representative began a review of China trade policy in 2021 and said she would keep all options open.

Why did Trump impose Section 301 tariffs on solar inverters?

In 2018, the Trump administration imposed Section 301 tariffs on a long list of Chinese goods that included solar inverters and AC modules after finding "China's acts, policies and practices related to technology transfer, intellectual property and innovation are unreasonable and discriminatory and burden or restrict U.S. commerce."

How will tariffs affect solar cells in 2024?

In 2024,tariffs for electric vehicle battery cells will increase to 25%,with energy storage tariffs following suit in 2026. The direct import of solar cells from China was less than 1% in 2021,underscoring the limited direct impact on solar cells these tariffs may have in the U.S. market.

How much would a solar cell cost if imported from China?

If one were to import solar cells from China today, they would cost a few cents to a nickel per watt. With this increase from 25% to 50% - a solar cell priced at five cents per watt would see its tariff increase from \$0.0125/Wdc to \$0.025/Wdc.

What has led to our current solar tariff environment?

There are a few notable events in recent history that have led to our current solar tariff environment: May 2017 - Solar cell manufacturers Suniva and SolarWorld petitioned the U.S. International Trade Commission (ITC) to impose a tariff on imported solar panels.

Will US tariffs on solar panels be a battleground in summer?

The US collected close to \$2.8 billion in duties on imported solar panels over the four years of the Trump administration. US import tariffs on solar cells and panels could remain a battlegroundinto the summer.
