Who is Terra-Gen?

Established in 2006, Masdar has a long-standing commitment to advancing renewable energy projects across the globe. The purchase of a 50% share in Terra-Gen represents another significant milestone as the company works to support the target set in the historic UAE Consensus to triple global renewables capacity by the end of this decade.

How will Masdar support Terra-Gen?

Masdar's 18-year history of funding, developing, owning and operating clean energy projects around the world will support Terra-Gen's ambitions to grow its renewable capacity and portfolio in the U.S. One of the world's fastest-growing clean energy companies, UAE-based Masdar first invested in the U.S. energy market in 2019.

Does ECP own Terra-Gen?

ECP, one of the largest private investors in power and renewable assets in the United States, has fully exited its position in Terra-Gen in connection with the closing of the transaction. Igneo Infrastructure Partners ("Igneo"), a global infrastructure investment manager, retains its existing 50 percent stake in Terra-Gen.

Does Terra-Gen have a wind farm?

Terra-Gen has successfully constructed the largest wind farm in the country and recently completed construction of the country's largest solar + energy storage project. Terra-Gen has a significant operations program that includes wind, solar and battery storage.
