When did Intertrust acquire CorpNordic?

In June 2015, Intertrust announced that it would acquire CorpNordic, which was finalised in August 2015. In 2016, the company announced that it would acquire Elian for \$625 million in cash, shares and debt. In June 2019, Intertrust announced the acquisition of technology solutions provider Viteos.

Did Blackstone buy InterTrust?

In December 2012, Blackstone Group announced that it would acquire Intertrust from Waterland Private Equity Investments, which was completed in April 2013. Reports stated that Blackstone paid EUR675 million for Intertrust. Intertrust held its initial public offering in September 2015 in Amsterdam, expecting to raise EUR475 million.
