What is the power supply system like in the Netherlands?

In the Netherlands, the power supply operates on 50Hz and 220V. The plugs on appliances are two prong round pins. There is a 24-hour number to call for electricity, gas or meter problems. If you suspect a gas leak, smell fumes or have a general power problem the national emergency number for electricity and gas is: 0800 9009
