

The United States purchases solar power from Vietnam

How much solar energy does Vietnam supply to the US?

In the first six months of the year, Vietnam supplied the U.S. with solar panels and modules worth \$3.3 billion, equal to 45% of all U.S. imports, up from less than 30% last year when full-year Vietnamese exports to the U.S. amounted to \$4 billion.

Why are Chinese-owned solar factories laying off workers in Vietnam?

How will US tariffs affect Vietnam's solar industry?

The U.S. Department of Commerce, the White House and China's commerce ministry did not respond to Reuters requests for comment. The most immediate visible impact of the latest U.S. tariffs, which have brought total duties to more than 300% for some producers, has been in Vietnam's solar sector.

What's going on with Solar Exports from Vietnam & Thailand?

As speculation about the trade probes began circulating this year, exports from Vietnam and Thailand surged, the American Alliance for Solar Manufacturing Trade Committee said in a complaint filed with Commerce, which followed its earlier petition in April to start the trade investigations.

Why did US solar imports jump 74% through August?

While U.S. solar import data shows shipments from Vietnam up almost 74% through August, industry analysts have attributed the jump to the frontloading of exports get ahead of this year's U.S. tariffs. Vietnam's government did not respond to requests for comment.
