For most solar panels, it's 25 years, but for their dual glass panels, Trina provides a 30 year product warranty. In addition to these two warranties, you are also protected by Australian Consumer Guarantees. #### Does Trina have a warranty?

Trina plans to increase its production by roughly 40% to around 50GW of panels this year. Trina provides their panels with both Product and Performance warranties. Product Warranties: These cover defects in panels due to problems with their manufacture. The defects may be obvious from when they're first installed or become apparent with use.

#### Does Trina Solar offer a warranty on duomax products?

(The power on the backside of the Duomax products is treated at 10% of the backside warranty power) Trina Solar reserves the right to provide other models of Products in replace-ment or addition of the defective Products if the defective Products are discontinued or otherwise una-vailable.

## Does Trina clamp II have a warranty?
