The Turks and Caicos Islands (TCI) are located to the southeast of the Bahamas, and north of the Dominican Republic. Providenciales is the third largest island in the Turks and Caicos. It's found on the western edge of the Turks and Caicos island chain. The country welcomes direct flights from many eastern US cities.
