

What is T&#252;rkiye's Africa policy?

Constructed on a historical foundation, T&#252;rkiye's Africa policy comprises establishing political, humanitarian, economic and cultural relations on bilateral, regional, continental and global levels. Significant progress has been made in our relations with the Sub-Saharan African (SSA) countries in numerous fields.

How does T&#252;rkiye work with African countries?

T&#252;rkiye shares its own historical experience, social, political and cultural accumulation as well as its opportunities and resources with African countries under the principle of "African solutions for African problems" and on the basis of mutual benefit.

What is Turkey doing in Africa?

Turkey's total trade volume with Africa has expanded from 3 billion dollars in 2003 to 26 billion dollars in 2021. Turkey's foreign direct investment (FDI) in Africa is close to 10 billion dollars. Turkish private companies are also monitoring Africa for investment and business opportunities.

Does Turkey have an Africa policy?

Because of that, Turkey has followed a certain Africa policy since 2005, and in the last decade, its presence in the continent has become more visible than ever. It has even hosted three Africa summits, the most recent of which was on 16-18 December 2021.

How much trade does T&#252;rkiye have with the African continent?

Our total trade volume with the African Continent has increased from 5,4 billion \$ in 2003 to 34,5 billion \$ in 2021. The volume of projects undertaken by Turkish contracting companies rapidly expanded and reached 77,8 billion \$ in the African Continent. T&#252;rkiye has established joint Business Councils with 45 African countries.

How many business councils does Turkey have in Africa?

Turkey's Foreign Economic Relations Board (DEİK) has 45 business councils in African countries in order to promote bilateral trade and mutual investment. Turkey's total trade volume with Africa has expanded from 3 billion dollars in 2003 to 26 billion dollars in 2021.
