What is a un3480 lithium ion battery?

The lithium-ion battery shipped separately from the laptop (standalone) is classified as UN3480. UN3480 is the UN ID for lithium ion batteries that are not packed with or installed in equipment. There is one entry in the DOT Hazardous Materials Table for UN3480.

What is the UN ID for a lithium ion battery?

The lithium-ion battery inside the laptop and providing power to the laptop (equipment) is classified as UN3481. The lithium-ion battery shipped separately from the laptop (standalone) is classified as UN3480. UN3480 is the UN ID for lithium ion batteries that are not packed with or installed in equipment.

What is a UN-no 3480 lithium-ion battery?

UN-No: 3480 or 3481 Lithium-Ion Batteries and Lithium-Ion batteries contained in equipment or packed with equipment. ADR Special Provisions 188,230,310,636 will apply and Packing Instruction P903,P903a and P903b. For further information, please visit the UNECE website by clicking here.

What happens if you don't use un3480 compliant packaging?

Failing to use the right, UN3480 compliant packaging for shipment of lithium batteries could have dire consequences for your business. This could extend to significant fines, jail sentences for individuals within your organisation and the reputational damage of having caused a (potentially fatal) accident.

What are the applicable regulations for lithium-ion batteries?

Applicable regulations; UN-No: 3480 (UN3480) or UN3481Lithium-Ion Batteries and Lithium-Ion batteries contained in equipment or packed with equipment Any Lithium-Ion batteries to be shipped are of the type proven to meet the requirements of each test set out in the UN Manual of Tests and Criteria, PartIII, sub-section 38.3

What is the service code for a lithium ion battery / cell?

Service Code HE. ACS - Select DG and mention PAX or CAO as applicable,in the restricted commodity type. UN3481,Lithium Ion Batteries /Cells - PI967 Section II. The equipment must be packed in strong rigid outer packaging.

Cells and batteries at a SoC of higher than 30% can only be shipped with the approval of the State of Origin and the State of the Operator, see Special Provision A331.

Since UN3480 lithium ion batteries are classified as hazardous materials, they are fully regulated as dangerous goods under United Nations regulations, the International Air Transport Association and other international regulatory bodies as well. What is ...

What is the difference between UN3480 and UN3481? The easiest way to explain this is that a laptop would be considered UN3481. The lithium-ion battery inside the laptop is providing power to the actual laptop (equipment). The battery inside that laptop is classified as UN3480. A battery shipped alone would be classified UN3480.
