Sungrow will supply 280 sets of its PowerTitan 2.0 liquid-cooled BESS units for the Hams Hall energy storage project, which is currently under development in North Warwickshire, England. The Hams Hall project, which was granted planning consent in May 2022, is a 350MW/1750MWh BESS project by Penso Power and Luminous Energy, funded by BW ...

BESS developer-operator Giga Storage has agreed a time-limited grid usage contract with Netherlands" TSO TenneT, the first of its kind, the firm claimed. The firm has concluded the first ever-time limited contract with ...

Battery energy storage system (BESS) developer NatPower UK has launched the first consultation for a proposed 1GW BESS in Yorkshire. The Mowbray Energy Storage project proposes installing a 1GW BESS and a transmission-connected substation on 93 acres of land to the north of the village of East Rounton, North Yorkshire. Lithium-ion batteries ...

Developer Eku Energy announced the financial close of the project in early August, with project financing arranged by Japanese bank MUFG. Energy-Storage.news noted at the time that while it marks MUFG"s first grid-scale BESS project financing transaction in its home country, the bank has previously participated in financing and investing in BESS projects in ...

In January, TotalEnergies acquired German BESS developer Kyon Energy, for EUR90 million (US\$98 million) upfront, plus further payments linked to development targets, while a few months back in October, the French company switched on a 255MWh Saft BESS at a solar PV plant in Texas, US.

Global renewable energy investment company Bluestar Energy Capital has announced the launch of Noveria Energy, a project development platform focused on European BESS. In a press release, Bluestar Energy Capital said that Noveria Energy will initially focus on the German market, where the company has over 2GWh of projects in the pipeline ...

experienced, U.S.-based solar farm developer and Ursa is being developed and built by Qcells USA ("Qcells"), also an experienced, U.S.-based solar farm developer. In total, Joint Applicants propose to acquire and construct 400 MW of solar generating and BESS nameplate capacity - the ownership of which will be shared among the Joint

That announcement coincided with two large-scale BESS in Sweden being progressed by their owners. IPP Ilmatar now has a 50MW PV, 20MW BESS in Knihult fully permitted to start construction in 2024 while developer SENS has signed a land lease in Hallsberg for a 50MW, earlier-stage project.

A BESS development may require many permits on local, state, and regional levels. Without previous

experience, it is hard to navigate which permits need to be completed, for whom, and by when. Because of this, a comprehensive permitting matrix is used to outline the required permits from each agency and what each permit authorizes a developer ...

However, the renumeration is not yet clear and developers are concerned about interconnection delays for their BESS assets. Projects between 50 and 100 MW require 30% of the nominal power to be storage; for projects between 100 to 200 MW, developers need 50%; and for projects above 200 MW, a special feasibility study must be carried out. 2

Renewable energy and energy storage developer Boom Power has successfully landed planning permission for a major battery energy storage system (BESS) project on the Isle of Anglesey, Wales, UK. The Carrog BESS is a 300MW/660MWh, 2-hour duration project located at Carrog Ganol, near Cemaes. The developers emphasise that the 38.7-acre project ...

BESS Consortium first-mover countries will be supported by resource partners including GEAPP, the African Development Bank (AfDB), the World Bank, Asian Development Bank (ADB), Inter-American Development ...

The UK has been ranked the world"s third most attractive country for BESS development, and major investment into the UK BESS sector has been on the rise. Power producer RWE has been making significant moves in the BESS sector, with the company recently announcing it was moving forward with proposals for a 350MW BESS to be located in Wales.
