With a larger stake in the shareholder structure, Korys wants to give Virya Energy the opportunity to pursue its ambitious global growth plans in sustainable hydrogen, wind, solar, and e-mobility.

#### What does virya energy do?

This includes the production of green energyin Europe through its subsidiaries Eoly Energy and Eurowatt, in Asia through its subsidiary Sanchore and a majority stake in Constant Energy, and energy distribution through its subsidiary DATS 24. Virya Energy is also involved in the development of sustainable hydrogen projects through Virya H2.

## Does Colruyt Group own virya energy?

Colruyt Group's shareholding in the Belgium-based energy company will decrease from 59.94% to 30%. Korys aims to bolster Virya Energy's capacity to achieve its ambitious international growth objectives.

## Will virya energy raise more than 55 Meur?
