VAT is an indirect tax that is levied on the consumption of goods and services in Eswatini, and is also levied on the importation of goods and services into Eswatini. It was introduced on 1 April 2012 to replace Sales Tax. Like Sales Tax, it is an indirect tax and it is levied on most goods and services at the rate of 15%.
