Can you sell solar energy through SEG?

No, at the moment, the only option for homeowners is to sell excess solar energy back to the grid or store it using battery storage for future use. Are there special requirements to sell energy through SEG? Yes, The SEG requires your solar panels to be under 5MW capacity and you must have an MSC certificate for installation.

Can you sell solar power in the UK?

This method of selling solar power was introduced by the UK Government in 2010 to promote the uptake of renewable energy. Homeowners and business owners who installed renewable technology could get paid for all the energy generated if they were registered with a provider under the scheme, whether used by them or not.
