How can a new coding technology verify the anti-counterfeiting of 9000 products?

The new coding technology can verify the anti-counterfeiting of 9000 products, with a single detection accuracy of 97% and a detection time of less than one minute.

Can a coding system detect anti-counterfeiting?

Finally,products were analyzed to detect their individual 12 coding data sites and the detected information was compared with the product code information in the anti-counterfeiting code database, which confirmed the system's detection capability for coding anti-counterfeiting.
