#### Did Younicos buy Xtreme Power?

(Prince declined to confirm or deny the \$200 million figure.) Last year, Younicos bought the assets of Xtreme Power, a bankrupt U.S. grid battery maker and control software vendor, adding about 60 megawatts of working projects to its portfolio.

Battery-based energy storage integration and development company Younicos is to provide a 1MW turnkey battery system for a solar project in Texas from PV developer OCI Solar Power. Younicos will design, engineer, integrate and construct the battery system, which uses technology from battery provider LG Chem.

Aggreko offers large battery storage solutions such as the Y.Cube. The 1 MW Y.Cube consists of lithium-ion battery blocks, a power conversion system, and proprietary energy storage software, allowing customers to achieve considerable savings in large energy projects.

German energy storage provider Younicos is introducing C& I battery storage systems on a rental basis. The company says service is ideal for offgrid industries such as the Australian mining sector.

Korean battery maker Samsung SDI supplied Younicos with batteries for its recent large-scale projects and also signed a deal in September last year to supply Green Charge Networks, a maker of customer-sited storage products for markets including solar and electric vehicles (EVs), with up to 25MWh of batteries.

Younicos will work within a new business unit, Aggreko Microgrid and Storage Solutions, which aims to deliver energy-storage-as-a-service, as well as full microgrid "as a service", built on Aggreko"s 9-GW fleet of distributed power generation assets.
